Arla Foods Finance A/S, Reg. No. 89622816 (the "Issuer") today announces its invitation, subject to the Offer and Distribution Restrictions below, to the holders (including any beneficial owners who hold their Notes via nominees or custodians) (the "Noteholders") of its outstanding notes outlined below (together, the "Notes") to tender any and all of their Notes for purchase by the Issuer for cash (the "Tender Offer") subject to the satisfaction of the New Financing Conditions (as defined below) being met.
